It is important to note that a guardian nominated in the will is not ensured of guardianship. This nomination is rather an indication of the deceased's wishes by which the High Court, being the guardian of all minor children will be guided in making its decision.
- 5. Nominate a competent executor to ensure one's wishes are carried out thoroughly and without unnecessary cost or delay as well as a trustee/s to assist with any testamentary trust created for beneficiaries.
- 6. Be mindful of the impact a divorce or maintenance order may have on the execution of one's wishes.
- 7. Care and provide for those who are financially dependent on you even after you have passed on.
- 8. Create and preserve wealth through different estate planning tools, products and vehicles available.
- 9. A living will which stipulates one's desires regarding future medical treatment/cessation thereof in circumstances in which one is no longer able to express informed consent.

The thought of discussing one's will can be unpleasant but not as devastating as avoiding or not having the conversation at all. In 2019, the Master of the High Court confirmed that as many as 75% of South Africans pass away without a valid will.
