

#### Investment objective

The primary objective of the Fund is capital appreciation in real terms over the investment horizon. The Fund is ideally suited to investors with a moderate to aggressive risk tolerance (measured in the base currency of the Fund) over an investment cycle of five years or longer. The diversified portfolio invests into a wide range of asset classes including cash, fixed income, equities, property and commodities. As this portfolio is global in nature, exposure will be taken in a wide range of currencies and markets.

#### Market commentary

Christmas came early for markets as November lived up to its reputation as being a strong month for equities historically, recording a bull rally in global markets. Data releases broadly supported the view that central banks have reached the peak of their tightening cycles, supporting both equities and fixed income, reinforcing market hopes of a soft landing. The S&P 500 Index ended the month up 9.1% and up 21% YTD, European indexes also ended the month in positive territory, with the MSCI Europe ex-UK Index gaining 7% over the month. Growth stocks and the tech sector rallied on the back of lower bond yields and healthy corporate earnings as they outperformed their value peers, with the financial sector in particular gaining from stronger interest margins and profits. Small caps rallied during November with the MSCI World Small Cap Index climbing 8% over the month. Large caps are still the outperformer year-to-date, by around 12 percentage points.

In the UK, the blue-chip FTSE-100 climbed 2.3% MoM and up 0.03% YTD. Inflation fell to 4.6% in October vs September's 6.7% YoY print, largely due to cheaper gas and electricity prices. A decline in service inflation could result in the Monetary policy holding rates despite elevated wage growth. There are signs indicating that economic activity has bottomed in the UK, with the flash November services Purchasing Managers Index moving above 50 into expansionary territory.

FTSE 100 TR finished the month up 2.3%.

In Europe, the German DAX gained 9.5% MoM, up 16.5% YTD, while the French CAC Index ended the month of November up 6.2%, up 12.9% YTD. On the economic front, October Euro area inflation and a dop, and be starting of the starting of

In emerging markets, MSCI China gained 2% in November buoyed by the MSCI Emerging Markets Index, which registered an 8% return over the month and is now up 6% YTD. Japan continues to be the year's top performer, up 5% MoM and up 29% YTD. China macro data surprised to the upside, with retail sales up 7.6% year-on-year in October. The housing market continues to depress growth and new home sales continue to decline on a vear-on-vear basis.

Emerging Markets (MSCI EM 50 NR) ended the month up 8.57%.
